The new Colorado Crash Report Form and DOR Reporting System

The DOR Crash Reporting System Now Accepts the DR 3447

What you Need to Know:

- Both electronic and paper/PDF versions of the DR 3447 are now being accepted by the Department of Revenue (DOR).
- The DR 2447 will also still be accepted but only for a limited time, beginning October 1, 2020 the DR 2447 acceptance by DOR will start to be phased out. If this is going to create a challenge to your agency please contact DOR at: Dor_drives_interfaces@state.co.us
- Agencies that submit the DR 2447 electronically to DOR need to work with their RMS vendor to make adjustments for submitting the DR 3447 ASAP.

Specifications for RMS vendors and agencies to make proper adjustments to submit the DR 3447 to DOR and how to conduct testing.

- For agencies collecting crash report data electronically, the RMS and/or Crash Reporting module will require modifications for the new form. Discuss with your RMS vendors *now* about the transition to the DR 3447, specifically covering:
 - Collecting the data to populate the modified form.
 - Printing out the data in the standard format.
 - Submitting the electronic form data to DOR.Determining if maintenance contracts cover the development of the DR 3447 or if a new contract is needed.

Potential Funding

Agencies that want to start collecting and submitting crash data electronically may be eligible for funding. STRAC funding is available to assist agencies with projects such as acquiring or implementing e-crash that includes electronic submittal of these records to DOR.

Agencies already collecting and submitting electronically may be eligible for funding to support their transition to the DR3447.
