<p>1. Describe your major areas of work experience/expertise:</p> <p>Most of my career has been in construction project administration. I have managed many highway and bridge construction projects for CDOT, both as a direct employee, and as a consultant. These include two Design Build projects, (Trex and Cimarron) as well as traditional Design Bid Build projects.</p>
<p>2. Describe your experience with construction claims:</p> <p>I only had two claims on my projects, both of which were resolved at the project level. One for AC content, and one for a Delay caused by a nesting raptor. As Area Engineer at CDOT I was involved in claim defense, and resolution for Regions 2 and 6 working as the Chief Engineers representative and successfully resolved a dozen claims in my tenure.</p>
<p>3. Describe your knowledge of construction contract law:</p>

My knowledge of construction contract law is limited to what I learned in my DRBI training, and what I learned working with the Colorado Attorney General's office while analyzing and defending claims for the CDOT Chief Engineer.

4. Describe your experience with construction contract administration:

I worked as an assistance project engineer from 1986 through 1999 when I became a project engineer (CEPM II). During this time I assisted the project engineer in construction contract administration, administering contracts valued between one and 18 million dollars. I was a PE I on the TREX design build project from 2000 to 2006 then went into management as a PE II. While a PE II Area engineer, I advised CDOT construction contract administrators on contract administration and claims avoidance / management. Upon retiring from CDOT I returned to construction contract administration. First as a consultant PE then managing consultant PE's and materials testing technicians, and advising CDOT construction contract administrators.

5. Describe your construction field experience:

I have been on every sort of project on the front range from simple signal installations, to region wide crack fill projects to intersection reconstruction and major highway and bridge reconstruction. I worked as inspector, tester, construction surveyor, assistant project engineer and project engineer. Some projects of note include the Wagon Road Park and Ride underpass taking NB RTD buses under SB I-25 to the wagon road park and ride, Pena Boulevard (from Chambers / I-70 through 40th Avenue) I was in charge of the walls and bridges, TREX – bridges from Broadway to Evans, Landscape installation, and ADA compliance.

6. Describe your DRB (or arbitration) training, certification, and experience:

I managed claims for regions 2 and 6 while an area engineer. During this time the area engineers re-wrote the claims portion of the specifications to include the use of DRB's in the claims process. Later, I received DRB training from the Dispute Resolution Board Foundation.

7. Describe your employment/retirement status and availability to serve on a DRB and geographical area:

I am retired at this time and completely available to serve on a DRB in Colorado. I would most easily serve on the front range, but any place in Colorado is a possibility.

DRB members are compensated as per Section 105 of the CDOT Specifications.
