TDM data across the state is fragmented and largely inaccessible, yet it is becoming increasingly more important in the transportation planning and TDM program development process. Commutifi – a Boulder-based tech company – has developed the world’s first TDM data platform that makes centralizing survey data easy and accessing it even easier. In this panel, we will hear from representatives from TMAs, the public sector, and private industry about how a centralized TDM data system will help improve transportation throughout Colorado in a data-driven and sustainable way.

Denver South will highlight the new WRK program, including marketing and outreach materials, participating employers, and template documents as well as initial responses like click-through rates and behavior change statistics. Next, Tom Pitstick will go over the recently released "Driving Change: The Colorado Employer's Guide to Green Mobility." This publication is a product of the Healthy Colorado Initiative, a partnership of the Colorado Forum and The Nature Conservancy. The Guide offers recommendations for commuters and businesses looking to decrease their carbon footprints. Timed to coincide with offices and businesses re-opening their doors after COVID-19 shutdowns, the Guide provides best practices on a wide range of transportation options, including public transit, electric vehicles, carpooling, vanpools, and cycling. It also highlights "Champions of Change" case studies of green mobility practices implemented by organizations around Colorado as well as a section on telework and flexible work schedules.

● **Data, Measurement, and Data Visualization Panel**

Data is important when designing and evaluating TDM projects of any scale. First, Catherine Sanders of Smart Commute will review TDM data basics. Next, Jim Eshelman of DRCOG will demonstrate how they used the Stages of Change model (also known as the Transtheoretical or Prochaska model) to evaluate registrations on the MyWayToGo.org website and how they collected data from registrants. Finally, FHU will present their new data visualization dashboard that tracks employee commuting behavior, quantifies emissions reductions from non-single-occupant vehicle travel, and how the data supports a larger TDM marketing strategy that highlights availability and use of alternative modes.

Will Jones will discuss the background, history, and outcomes of Greeley Evan Transit's Ride Free with ID program. Finally, Erwin Germain will give a brief overview of their carpooling app, TreadShare.

The RMS program funded many projects that involved TDM best practices, linking downtown revitalization with bike, pedestrian, and transit improvements. Additionally, Lisa Streisfeld of CDOT's Office of Innovative Mobility will discuss new grants and how Policy Directive 1601 incorporates TDM for the Interchange Approval process.

Shoshana Lew, Colorado Department of Transportation

Shoshana M. Lew was appointed as the Executive Director for CDOT in December 2018. She is charged with leading the department in planning for and addressing Colorado's transportation needs as well as overseeing 3,000 employees statewide and an annual budget this year of approximately \$2 billion. Prior to coming to Colorado, she served as the chief operating officer for the Rhode Island Department of Transportation. Additionally, she was the chief financial officer and assistant secretary for budget and programs for the U.S. Department of Transportation (USDOT), as well as the deputy assistant secretary for transportation policy at the USDOT.

Lew has also worked in other areas of the federal government, including the U.S. Department of the Interior, the Office of Management and Budget, and Domestic Policy Council within the White House. Prior to her federal service, she worked at the Brookings Institution.

She is a graduate of Harvard College with a bachelor's degree in history. Lew also has a master's degree in history from Northwestern University.



David Straus, Association for Commuter Transportation

David Straus has the honor of serving as the Executive Director of the ACT, the premier organization for the TDM industry. As Chair of the Northwest Parkway Public Authority, Stuart was an active member of the International Bridge Tunnel and Turnpike Association (IBTTA) and a key negotiator for the Northwest Parkway's Concession Lease Agreement in 2007. In 2015, Stuart received DRCOG's Distinguished Service Award. She serves on the Board of Directors of UHealth Broomfield Hospital and UHealth Longmont Hospital.

Stuart is currently the Executive Director of Smart Commute Metro North, a non-partisan, non-profit, transportation management organization, serving the north metro region by working to promote mobility options that reduce congestion and improve air quality. 
Allison Crump, City of Boulder

During many of his solo drives across Colorado, he realized how urgent it has become to decrease traffic and pollution. This is why he started TreadShare, a carpool app that connects drivers and passengers heading in the same direction so they can share their route and its associated costs. TreadShare will launch in November and aims to make Colorado more sustainable.



Audrey DeBarros, Commuting Solutions

Audrey DeBarros keeps the wheels of Commuting Solutions, and the northwest metro region, rolling smoothly. She leads their advocacy efforts, financial planning, coalition building, and everything in between. DeBarros not only manages the internal functions of the organization but is Commuting Solutions' external voice. Her efforts are focused on expanding their partnerships, coalition, and member base to improve the regional transportation system. Her leadership with local, regional, and state officials results in positive change and the efficient movement of people, not vehicles.
