Avon, Town of	APP-042102	Vehicle Replacement / Gap Funding	Procurement was done for this Bus in November of 2023, according to applicant. Pre-purchase authorization period per CDOT Controller is 90 days. As such, any contract for add'l funds would have had to have been executed no later than March 1, 2024. We cannot add funds to this project.

The crews do all the lawn work, take trash to the landfill, haul heavy items for different jobs..." and travel nurses. Non-service revenue vehicles must be used in support of transportation services. Vehicles used by staff for the tasks described by the applicant are excluded from funding consideration.

Received \$238,484 in CTE funds for this request.
