## Silver Plume On-Ramp to Interstate 70 Reopens

Clear Creek County – On, Tuesday, November 19, 2019, the Colorado Department of Transportation reopened the westbound on-ramp to Interstate 70 from Silver Plume between Mile Post (MP) 225.25 to 225.60. Construction will continue throughout the winter season with activities occurring off of the traveling roadway Monday - Friday 7 a.m. to 5 p.m. In addition, there will be temporary ramp closure for the WB I-70 on-ramp Monday - Thursday, 9 a.m. to 3 p.m., as weather permits.

This fall, crews have been working on removing the existing deteriorating sound wall. Work this winter will consist of driving steel pile and constructing concrete pile caps for the new sound wall. The new sound wall will improve safety, functionality, durability and aesthetics. Starting the spring of 2020, the placement of concrete panels for the new sound wall will begin as well as, the construction of a new storm drainage system that will run across Water St and along Garfield St improving drainage along the WB I-70 on-ramp.

### TRAVEL IMPACTS

Construction will take place Monday-Thursday, 9 a.m. to 3 p.m. per the following schedule:

- November 20 to March 31, 2020: The WB on-ramp will be open for the winter. Periodic 9 a.m. to 3 p.m. closures of the WB onramp may take place as conditions permit during the winter.
- April 1 to June 2020: The WB I-70 Silver Plume on-ramp will be closed permanently until June 2020.
- The project is scheduled to be completed June 2020, barring weather and/or shipment delays.

### REMEMBER: SLOW FOR THE CONE ZONE

The following tips are to help you stay safe while traveling through maintenance and construction work zones.

- Do not speed in work zones. Obey the posted speed limits.
- Stay Alert! Expect the unexpected.
- Watch for workers. Drive with caution.
- Don't change lanes unnecessarily.
- Avoid using mobile devices such as phones while driving in work zones.
- Turn on headlights so that workers and other drivers can see you.
- Be especially alert at night while driving in work zones.

- Expect delays, especially during peak travel times.

- Anticipate lane shifts and merge when directed to do so.
